#### Application Requirements:

**The number of children who can be accepted is limited.**

**All enrollment is based on the time a FULLY COMPLETED application is received.**

**FEES (sliding scale):** There is a **camp fee (per child)** that is due with each application. The *Camp Fee* covers all 7 weeks for 1 child. Cash, check or money order accepted. Please make checks payable to "A's & Aces".

**Regular Fee: \$520    Reduced Fee: \$420**

**Very Reduced Fee: \$210    Extremely Reduced Fee: \$140**

**Lowest Fee: \$70**

In order to qualify for any fee reduction, you must submit income documentation to show cause. The fee reduction scale is included at the end of this document.

**All parts of the application must be fully** completed, including:

1. A's & Aces Questionnaire
2. Brief essay by a child about why he/she wants to participate in this camp
3. Copy of school report card
4. A's & Aces Camp Agreement
5. A's & Aces Parent Permission, Waiver and Release Form

## **Camp Requirements/Rules:**

- 🔗 Campers must bring their own notebook (i.e., a journal they will use throughout the camp).
- 🔗 Campers must bring their own plastic water container/squeeze bottle.
- 🔗 Campers must wear tennis shoes as well as shorts and other appropriate attire.
- 🔗 Attendance is mandatory. All absences must be excused.
- 🔗 Campers must bring their own lunch (we will help with proper storage) and eat breakfast **prior** to coming to the camp every morning
- 🔗 All campers are expected to enter and compete in at least two (2) tournaments NOT hosted by A's & Aces this summer. We will help to find the right tournaments for each child, and (if meeting both financial and merit-based criteria) help with some expenses.
- 🔗 A parent must attend the mandatory parent orientation on June 3 at UNO Tennis Center

**Violations of camp rules, including unexcused absences, may result in dismissal.**

**There is a mandatory parent orientation scheduled on Sunday June 3 at 3:00 pm at the UNO Tennis Center. We will discuss daily schedule, tournament training activities/preparation, suggest tournaments, etc., as well as answer any questions you may have.**

### **Drop off/pick-up policies:**

**Drop off: 8:45-9:00 am**

**Pick-up: 3:00– 3:15 pm**

**After 3:15 late pick up charges will be assessed (\$5 for each 15 min increment)**

**Before & After Care:** Unless there are sufficient requests for the services to cover costs, Before & After Care will not be offered this year. (There was very low need for these services last year)

**Parent Permission, Waiver and Release Form**

I/We, the parents/guardians of \_\_\_\_\_, understand the nature and purpose of the training and instruction planned. We declare that the above named student is of sound physical and mental condition for instruction and training in tennis or exercise classes, reading and life skills, making no declaration to the contrary to A's & Aces or its partner(s). We grant our son/daughter permission to participate in the summer camp and these academic/life skills/tennis activities. We understand that there are limited places in this camp and, if accepted, we promise to bring our child on time each day. We also understand that disruptive behavior or violations of camp rules will result in dismissal from camp.

We agree to waive all rights, release and hold harmless A's & Aces and its summer camp partners (University of New Orleans), their boards of directors, officers, partners, agents, employees, service-learners and volunteers, from any and all liability, claims, suits, demands, judgments, costs, interest, and expenses (including attorneys' fees and costs) of any kind arising from or related to such activities, including any accident or injury to our child or myself and the costs of medical services. Neither A's & Aces nor its summer camp partners will provide student accident insurance coverage for participating students while participating in the A's & Aces program.

In the event of an injury requiring medical attention, we grant permission to the supervising party (including volunteers) to attend to our son/daughter. If the injury warrants further medical attention, we give our permission to the supervising party (including volunteers) to take our child to a physician, dentist, or hospital if deemed necessary and we accept financial responsibility for all such medical attention.

We give A's & Aces and its partners the absolute right and permission to use our son's/daughter's photograph or videography in promotional materials and publicity efforts. We understand that the photographs may be released to newspapers and may be used in other publications, as printed as, direct-mail, electronic media, or other forms of promotion. We further release A's & Aces, its partners, photographers, and their agents from liability for any violation of any personal or proprietary right we may have in connection with such use.

We understand that information contained in my child's school record is confidential. However, we give permission to my child's school and its administrators to provide access and release to A's & Aces school records relating to my child, specifically including but not limited to all free/reduced lunch records or other documents relating to household financial status, documents establishing residency, report cards and other academic, attendance and behavior information, to allow best opportunities to assist my child and to compile and evaluate data relating to school and program efficacy.
